**1. Passport Copy**

- Front page (biodata page)
- Passport validity must be at least 6 months from the date of travel.

**2. Visa / Student Pass**

- Copy of a valid Student Pass
- Include any new endorsement if applicable

**3. Student Verification Letter**

- Issued by the university/college confirming active student status and current semester.

**4. Student ID Card (Home Institution)**

- For identity verification.

**5. Flight Ticket Proof / Travel Itinerary**

- Return flight itinerary to and from Sabah.

**6. Consent/Authorization Letter from Home Institution**

- Stating approval for the student to participate in the program in Sabah.

**7. Program Fee Payment Receipt**

- Proof of payment to the organiser's account.

**8. Additional Documents (If requested by immigration)**

- Accommodation details during the program (e.g., hostel or homestay provided by organiser).

**9. Health Insurance / Medical Insurance**

- Copy of active student health insurance (mandatory for all international students).
